THE REPORT OF THE MANAGING COMMITTEE FOR THE YEAR

ENDED 31ST MARCH 2021

Dear Members,

It gives me great pleasure in presenting before you the 60th Annual Report together with the audited statements of accounts of the Society for the year ended on 31st March 2021

During the year under report, the Managing Committee conducted 21 meetings. All the matters concerning the society were discussed & deliberated extensively before taking any decisions. In case of any difference of opinion that arose in the meetings, the President / Chairman used to judiciously intervene, which ensured that, the decisions were taken as per the rules and regulations governing the Society and which also ensured unanimous decision by the committee. Most of the committee members actively got involved in the day to day activities of Society and ensured the steady growth of the Society and Credibility.

The committee had examined many suggestions & proposals put forth. During the year, 364 ordinary loan applications were sanctioned and the loan to the extent of Rs. 20,33,42,600 and the Emergency Loan amounting to Rs. 66,38,000 (79 Applications) were disbursed. Due to direct recovery from salary, the status of recovery of loan is good and recovery in the area of collection of outstanding loan is extremely encouraging. The continued co-operation of the managing committee members in affairs of the society would certainly encourage the society for better performance in the coming years.

This year the Society could earn total income of Rs 2,77,12,095/- as against Rs 2,88,37,745/- in the preceding year. From the audited statement, it can be seen the liability on Fixed Deposits is decreased by Rs 1,04,609/- (Rs 2,74,241/- minus Rs 3,78,850/-). The rate of interest on Fixed Deposit is 4.5% for one year and on pre-matured withdrawal, rate of interest will be reduced by 2%.

During the year, 15 claims under "**Death Benefit Scheme**" have been settled and the amount aggregating to Rs 31,74,400 was paid to the families of the deceased members of which details are as under. Since the inception of the scheme in 1970, till the end of the year under report, Society could settle 693 cases and the amount disbursed amounts to Rs 4,31,71,342/-.


